PLEASE TAKE NOTICE that on December 7, 2016, Active Mind Technology, Inc. (“Active Mind Technology, Inc.” or “Assignor”), a Delaware corporation (EIN: 99-0363892) with offices at 653 Bryant Street, San Francisco, California 94107, as assignor, made a General Assignment for the Benefit of Creditors (the “Assignment”) to Active Mind (ABC), LLC (“Assignee”), a California limited liability company, as assignee, pursuant to California state law. Please note that with the exception of the relationship created by the Assignment, and despite their similarity in name, Assignor and Assignee have no corporate affiliation to each other. Pursuant to the Assignment, Assignor transferred ownership of all of its rights in tangible and intangible assets (collectively, the “Assets”) including furniture, equipment, software, source code, trademarks, domain names, and other intellectual property to Assignee for liquidation. Assignee shall attempt to liquidate intangible Assets and, at the same time, conduct a process to monetize the furniture and equipment, and shall wind down Active Mind Technology, Inc. and distribute the net liquidation proceeds to creditors of Active Mind Technology, Inc. who timely submit claims as instructed below.
