**NOTICE OF ASSIGNMENT FOR
THE BENEFIT OF CREDITORS
AND DEADLINE FOR
SUBMITTING CLAIMS**

TO ALL CREDITORS AND EQUITYHOLDERS OF AVNI NETWORKS, INC. AND OTHER PARTIES IN INTEREST:

PLEASE TAKE NOTICE that on December 19, 2016, Avni Networks, Inc. (“Avni” or “Assignor”), a Delaware corporation (EIN: 30-0795130) with offices at 2901 Tasman Drive, Santa Clara, California 95054, as assignor, made a General Assignment for the Benefit of Creditors (the “Assignment”) to Avni (ABC), LLC (“Assignee”), a California limited liability company, as assignee, pursuant to California state law. The Assignment and the wind up and dissolution of Avni previously were approved by Avni’s stockholders holding a majority of the company’s stock. This correspondence constitutes notice under Section 228(e) of the Delaware General Corporation Law for corporate action taken without a stockholders’ meeting by less than unanimous written consent of the Company’s stockholders.

PLEASE TAKE FURTHER NOTICE that with the exception of the relationship created by the Assignment, and despite their similarity in name, Assignor and Assignee have no corporate affiliation to each other. A true and correct copy of the document evidencing the Assignment can be downloaded from the following website (www.FileAClaim.info/Avni-ABC). Pursuant to the Assignment, Assignor transferred ownership of all of its rights in tangible and intangible assets (collectively, the “Assets”) including furniture, equipment, software, source code, patents, trademarks, domain names, and other intellectual property to Assignee for liquidation. Assignee shall attempt to liquidate intangible Assets and, at the same time, conduct a process to monetize the furniture and equipment, and shall wind down Avni and distribute the net liquidation proceeds to creditors of Avni who timely submit claims as instructed below.

PLEASE TAKE FURTHER NOTICE that all entities asserting any claim against Avni must submit a proof of claim and proper supporting documentation no later than July 17, 2017 (the “Bar Date”). Claims can be filed using the following website (www.FileAClaim.info/Avni-ABC). Alternatively, documentation may be requested by sending a self-addressed, stamped envelope to the following address:
