PLEASE TAKE NOTICE that on December 5, 2016, Avogy, Inc. (f/k/a ePowerSoft, Inc.) (“Avogy” or “Assignor”), a Delaware corporation (EIN: 27-2434403) with offices at 677 River Oaks Parkway, San Jose, California 95134, as assignor, made a General Assignment for the Benefit of Creditors (the “Assignment”) to Avogy (ABC), LLC (“Assignee”), a California limited liability company, as assignee, pursuant to California state law. Please note that with the exception of the relationship created by the Assignment, and despite their similarity in name, Assignor and Assignee have no corporate affiliation to each other. A true and correct copy of the document evidencing the Assignment can be downloaded from the following website (www.FileAClaim.info/Avogy-ABC). Pursuant to the Assignment, Assignor transferred ownership of all of its rights in tangible and intangible assets (collectively, the “Assets”) including furniture, equipment, software, source code, trademarks, domain names, and other intellectual property to Assignee for liquidation. Assignee shall attempt to liquidate intangible Assets and, at the same time, conduct a process to monetize the furniture and equipment, and shall wind down Avogy and distribute the net liquidation proceeds to creditors of Avogy who timely submit claims as instructed below.

PLEASE TAKE FURTHER NOTICE that all entities asserting any claim against Avogy must submit a proof of claim and proper supporting documentation no later than July 3, 2017 (the “Bar Date”).
