**NOTICE OF ASSIGNMENT FOR

TO ALL CREDITORS AND EQUITYHOLDERS OF LOCALE HOSPITALITY, INC. AND OTHER PARTIES IN INTEREST:

PLEASE TAKE NOTICE that on January 22, 2026, Locale Hospitality, Inc. (“Locale Hospitality” or “Assignor”), a Delaware corporation (EIN: 83-2694417) with offices at 1601 Elm Street, Dallas, Texas 75201, United States as assignor, made a General Assignment for the Benefit of Creditors (the “Assignment”) to Locale Hospitality (ABC), LLC (“Assignee”), a Texas limited liability company, as assignee, pursuant to Texas common law. The Assignment and the wind up and dissolution of Assignor previously was approved by Assignor’s Stockholder holding all of the company’s capital stock. This correspondence constitutes notice under Section 228 of the Delaware General Corporation Law for corporate action taken without a Stockholder meeting of the Company’s Stockholder.

PLEASE TAKE FURTHER NOTICE that with the exception of the relationship created by the Assignment, and despite their similarity in name, Assignor and Assignee have no corporate affiliation to each other. A true and correct copy of the document evidencing the Assignment can be downloaded from the following website (<https://fileclaim.info/localehospitality-abc/>). Pursuant to the Assignment, Assignor transferred ownership of all its rights in remaining tangible and intangible assets (collectively, the “Assets”) to Assignee for liquidation. Assignee shall attempt to liquidate the Assets and shall wind down Assignor and distribute the net liquidation proceeds to creditors of Assignor who timely submit claims as instructed below.

PLEASE TAKE FURTHER NOTICE that all entities asserting any claim against Assignor must submit a proof of claim and proper supporting documentation no later than August 19, 2026 (the “Bar Date”). Alternatively, claim forms and related documentation may be requested by sending a self-addressed, stamped envelope to the following address:
