PLEASE TAKE NOTICE that on January 22, 2026, Mint House Tennessee 01 LLC (“Mint House Tennessee 01” or “Assignor”), a Tennessee limited liability company (EIN: 84-4637500) with offices at 1601 Elm Street, Dallas, Texas 75201, United States as assignor, made a General Assignment for the Benefit of Creditors (the “Assignment”) to Mint House Tennessee 01 (ABC), LLC (“Assignee”), a Texas limited liability company, as assignee, pursuant to Texas common law. The Assignment, the wind up, and dissolution of Assignor, was previously approved by Assignor’s sole Member in accordance with the Assignor’s governing documents and applicable law.

PLEASE TAKE FURTHER NOTICE that with the exception of the relationship created by the Assignment, and despite their similarity in name, Assignor and Assignee have no corporate affiliation to each other. Pursuant to the Assignment, Assignor transferred ownership of all its rights in remaining tangible and intangible assets (collectively, the “Assets”) to Assignee for liquidation. Assignee shall attempt to liquidate the Assets and shall wind down Assignor and distribute the net liquidation proceeds to creditors of Assignor who timely submit claims as instructed below.

PLEASE TAKE FURTHER NOTICE that all entities asserting any claim against Assignor must submit a proof of claim and proper supporting documentation no later than August 19, 2026 (the “Bar Date”).
