**NOTICE OF ASSIGNMENT FOR  
THE BENEFIT OF CREDITORS  
AND DEADLINE FOR  
SUBMITTING CLAIMS**

**TO ALL CREDITORS AND EQUITYHOLDERS OF TRESLE.AI, INC. AND OTHER PARTIES IN INTEREST:**

**PLEASE TAKE NOTICE** that on January 30, 2026, Tresle.ai, Inc. (“Tresle” or “Assignor”), a Delaware corporation (EIN: ) with offices at 555 Twin Dolphin Drive, Suite 350, Redwood City, CA 94065, United States as assignor, made a General Assignment for the Benefit of Creditors (the “Assignment”) to Tresle (ABC), LLC (“Assignee”), a California limited liability company, as assignee, pursuant to California state law. The Assignment [and the wind up and dissolution] of Assignor previously was approved by Assignor’s Stockholders holding the requisite majority of the company’s shares of capital stock. This correspondence constitutes notice under Section 228(e) of Delaware for corporate action taken without a Stockholders meeting by less than unanimous written consent of the Company’s Stockholders.

**PLEASE TAKE FURTHER NOTICE** that with the exception of the relationship created by the Assignment, and despite their similarity in name, Assignor and Assignee have no corporate affiliation to each other. A true and correct copy of the document evidencing the Assignment can be downloaded from the following website <https://fileclaim.info/tresle-abc/> beginning on March 2, 2026. Pursuant to the Assignment, Assignor transferred ownership of all its rights in tangible and intangible assets (collectively, the “Assets”) including but not limited to all Intellectual Property, office equipment, and other recoveries to Assignee for liquidation. Assignee shall attempt to liquidate the Assets and, at the same time, conduct a process to monetize the furniture and equipment, and shall wind down Assignor and distribute the net liquidation proceeds to creditors of Assignor who timely submit claims as instructed below.

**PLEASE TAKE FURTHER NOTICE** that all entities asserting any claim against Assignor must submit a proof of claim and proper supporting documentation no later than July 29, 2026 (the “Bar Date”).
